In the event my application is approved, I agree as a condition of membership to complete the code of ethics training, fair housing training, and any orientation course of the Greater Philadelphia Association of REALTORS®, and otherwise on my own initiative to thoroughly familiarize myself with the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS®, including the duty to arbitrate business disputes in accordance with the Code of Ethics and Arbitration Manual of the Association and the Constitutions Bylaws, and Rules and Regulations and duty to arbitrate. I further agree to complete satisfactorily a reasonable and nondiscriminatory written examination covering such Code, Constitutions, Bylaws, Rules and Regulations, and duty to arbitrate as applicable. I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the aforementioned Code of Ethics Constitutions, Bylaws, Rules and Regulations, and duty to arbitrate, all as from time to time amended. Finally, I consent and authorize the Association, through its Membership Committee or otherwise, to invite and receive information and comment about me from any Member or other person, and I agree that any information and comment furnished to the Association by any Member or other person in response to any such invitation shall be conclusively deemed to be privileged and not form the basis of any action by me for slander, libel, or defamation of character.
NOTE: Applicant acknowledges that if accepted as a Member and he/she subsequently resigns or is expelled from membership in the Association with an ethics complaint or arbitration request pending, the Board of Directors may condition renewal of membership upon applicant's verification that he/she will submit to the pending ethics or arbitration proceeding and will abide by the decision of the Hearing Panel; or if applicant resigns or is expelled from membership without having complied with an award in arbitration, the Board of Directors may condition renewal of membership upon his/her payment of the award, plus any costs that have previously been established as due and payable in relation thereto, provided that the award and such costs have not, in the interim, been otherwise satisfied.
NOTE: Applicant acknowledges that the association will maintain a membership file of information which may be shared with other boards/associations where applicant subsequently seeks membership. This file shall include: Previous applications for membership; al final findings of Code of Ethics violations and violations of other membership duties within the past three (3) years; pending complaints alleging violations of the Code of Ethics or alleging violations of other membership duties; incomplete or pending disciplinary measures pending arbitration requests; and information related to unpaid arbitration awards or unpaid financial obligations to the association.

Tax deductibility: \$45 of the NAR dues qualify as fully deductible (NAR National Advertising Campaign annual surcharge). 35% of the remaining NAR dues are non-deductible, 5% of PAR dues and 25% of the PAR application fee are non-deductible per IRS lobbying disallowance rules.

Primary applicants who have not held membership in Pennsylvania previously must pay both application fees at the time of application.

Secondary applicants, who hold primary membership in another association, pay only the local (GPAR) portion of dues. Secondary applicants who are interested in also belonging to the state association (PAR) must contact PAR directly at 717-561-1303. Note that secondary membership with PAR is required to gain access to the Pennsylvania standard forms library. Application to GPAR must be made prior to subscribing to Bright MLS to receive your shareholder discount.
